**ACTIVE INGREDIENT:** Contains 125g/litre myclobutanil, in the form of a capsule suspension.

**WARNING:** May cause eye irritation, avoid contact with the eyes. May cause reproductive/development damage or organ damage from repeated oral exposure at high doses.

**FIRST AID:** If swallowed **DO NOT** induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Do not scrub the skin. If splashed in eyes, wash out immediately with water for at least 15 minutes. If inhaled move the victim to fresh air immediately. Begin artificial respiration if breathing has stopped.

<b>PIPFUIT</b> Black-Spot and Powdery Mildew	40ml per 100 litres of water	Apply <b>Pipstar encaps</b> mixed with a suitable protectant, as a high volume dilute application at 7-10 day intervals, commencing at cluster stage.  For concentrate spraying adjust dilution rates accordingly.  During severe periods of black spot infection ("Mills Periods"), re-apply <b>Pipstar encaps</b> within 4 days of rainfall

**RESISTANCE:** Resistance to this fungicide and related DMI products could develop in some disease situations from repeated use. To minimise this risk use strictly in accordance with the label instructions. Always mix with a blackspot protectant spray. Do not use more than 4 applications during a season.

**WITHHOLDING PERIOD:** P이프ruit - Do not apply within 35 days of harvest.

**RAINFALL:** Rain within 1 hour following treatment may reduce effectiveness.

**COMPATIBILITY:** May be tank mixed with commonly used fungicides and insecticides except for highly alkaline materials such as Bordeaux mixture or lime sulphur. Do not tank mix with dichlofuanid.

**SHELF LIFE:** When stored appropriately, this product should show no significant degradation for 2 years from the date of manufacture. Contact your supplier for further information about the use of any product that is older than this.
